- I coordinated for the Faculty of Economics of the Eastern Piedmont University: from 1999 to 2008, the Degree Course on “Business Economics” implemented in Casale Monferrato since 1999; and, from 2001 to 2004, the new Degree Course on “Tourism Promotion and Management” implemented in Novara.
- I promote and organize since 2001 the “Tourism Days”, an annual Italian meeting of researchers, decision-makers and entrepreneurs in tourism.
